Dear Sir or Madam:

We represent Nirmal Intellectual Property Corporation ("NIPC") which is the owner of copyrights in the video, audio and transcripts of talks (the "Talks") given by Shri Mataji Nirmala Devi. It has come to our attention that a certain website located at [www.adishakti.org](http://www.adishakti.org) (the "Site") features a large number of audio and video copies of the Talks copied without authorization from NIPC. The WHOIS information for the Site indicates that you provide hosting for this infringing material. This letter is to serve notice of this infringement pursuant to 17 U.S.C. § 512.

Attached is a list of Talks covered by NIPC's copyrights that are infringed on the Site. We hereby state that we believe in good faith that the use of these Talks on the Site is not authorized by NIPC, its agents, or the law. We further state that the information contained in this letter is accurate and under penalty of perjury we state that we are authorized to act on behalf of the copyright owner of the Talks infringed by the Site.

We therefore request that you immediately deny access to your servers to any third-parties seeking to access the Talks on the Site, or remove the Talks from your servers.
